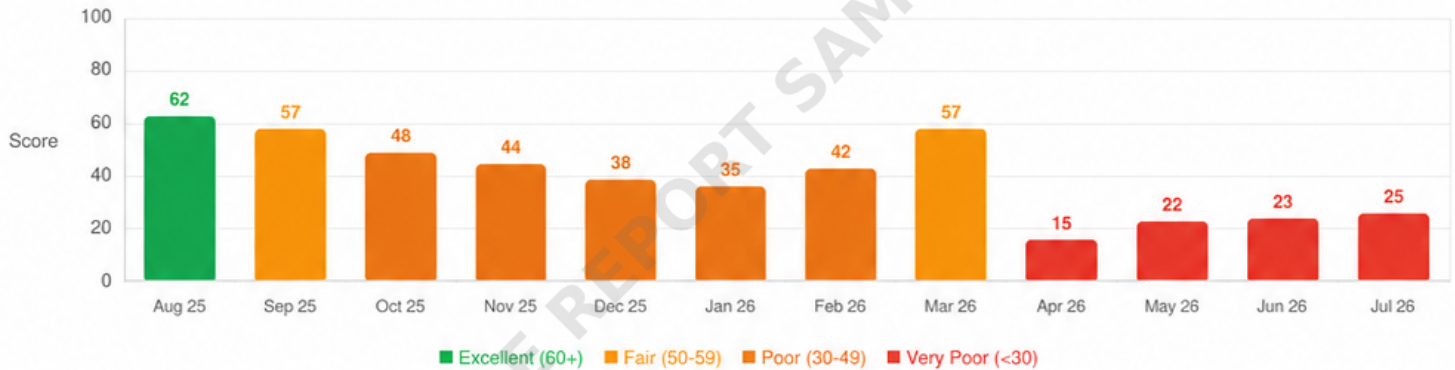

High Mountain Farms Faces Mounting Financial Pressure Amid Colorado Market Contraction

Boulder-based cultivator High Mountain Farms LLC is reportedly struggling with cash flow challenges as wholesale flower prices in Colorado continue their downward slide. Industry sources indicate the company has fallen behind on payments to several key vendors, including nutrient suppliers and testing laboratories. CEO Jordan Whitfield told MG Magazine that the company is “actively restructuring its operations to align with current market realities” and expects to return to profitability by Q3 2026. The company recently applied for a processing license to diversify into concentrates and edibles, a move analysts say could help stabilize revenue if approved.

Colorado Cultivators Report Record Vendor Payment Delays as Wholesale Prices Drop 22%

A new survey from MJBizDaily reveals that Colorado cannabis cultivators are taking an average of 47 days to pay vendors, up from 31 days a year ago. High Mountain Farms was cited among several Boulder County operators experiencing significant accounts payable backlogs. The report notes that at least three lawsuits have been filed against the company by suppliers seeking to recover unpaid balances totaling over \$125,000. Industry consultant Maria Chen commented, “This is a systemic issue across the Colorado market, not unique to any single operator, but companies with thin margins are feeling it first.”
